RESTORATION RECOGNITION ORDER

WHEREAS, recognition was granted to the institution namely, **SMT. SURAJBA COLLEGE OF EDUCATION, JUHU ROAD (NORTH), JUHU, MUMBAI, MAHARASHTRA (WRC/APW00531/113073)** under section 14 of NCTE Act. 1993 for conducting **B.ED.** course vide order dated 30.11.2000 for an annual intake of 80 students.

AND WHEREAS, the AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institutions and the reply was received on 09.01.2015.

AND, WHEREAS, Revised Recognition order was issued for one basic unit of (50 students) to the institution on 31.05.2015.

AND, WHEREAS, the matter was placed in 255th Meeting of WRC held on June 22-24, 2016 and the Committee decided that "...Follow up of Revised Orders for B.Ed. courses: The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item"

AND WHEREAS, the Show Cause Notice of compliance issued on 02.01.2017 and reply submitted by the institution on 19.01.2017.

AND WHEREAS, the reply was placed in 287th Meeting held on January 30-31, 2018 of WRC and the Committee decided that "...In response to the Show Cause Notice dated 02.01.2017, the institution has not submitted the required documents.

Hence, Recognition is withdrawn from the academic session 2018-2019."

AND WHEREAS, the Withdrawal Order issued on 02.02.2018. The institution filed a appeal to the appellate authority.

AND WHEREAS, the appeal order dated 13.08.2018, "The matter deserved to be remand back the case to WRC for reconsideration. Appellant is required to resubmit to WRC copies of i) Approved faculty list, ii) FDRs and iii) Certificate issued by Municipal Corporation of Greater Mumbai in support of built up area within 15 days of the issue of appeal order. WRC is required to consider the documents and issue fresh speaking orders on merits.

NOW THEREFORE, the Council hereby remands back the case of Smt. Surajba College of Education, Juhu, Juhu Road North, Mumbai, Maharashtra to the WRC, NCTE, for necessary action as indicated above."

AND WHEREAS, the matter was placed in 296th Meeting held on August 28 - 29, 2018 of WRC and the Committee decided that "... Consequent to the appeal order, the institution has submitted various documents as required. Since the documents are in order, the Recognition is restored and permitted to continue with one unit."

NOW THEREFORE, the recognition of SMT. SURAJBA COLLEGE OF EDUCATION, JUHU ROAD (NORTH), JUHU, MUMBAI, MAHARASHTRA for conducting B.Ed. course with an annual intake of 50 students (one basic unit) is restored and permitted to continue with one unit.
